Refund Policy: A full tuition refund will be issued if your child is withdrawn **prior** to the last Saturday in August. An 80% tuition refund will be issued for withdrawals between the last Saturday in August and the first day of school. A partial, prorated tuition refund will be issued if your child is withdrawn **after** the first day of school. The \$50.00 registration fee is not refundable.
